In Michael M. v. Superior Court of Sonoma County, the United States Supreme Court decided in Michael M. v. Superior Court of Sonoma County, 450 U.S. 212 (1981), that a state's statutory rape law is constitutional even if it is applied to a minor who is a victim of a consensual relationship. The case was decided by a 5-4 majority, with Justice Rehnquist writing the majority opinion. The dissenting opinion was written by Justice Brandenburg.
